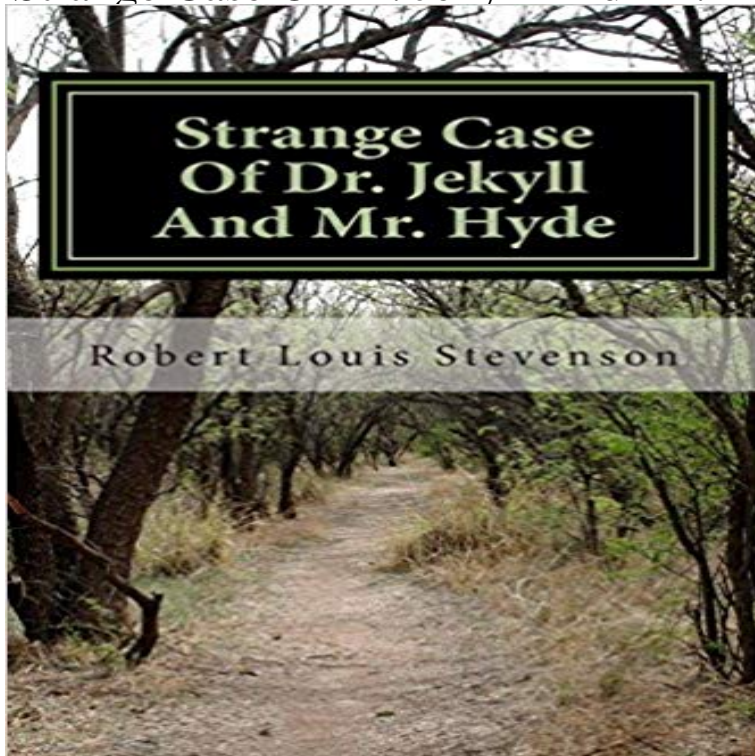


Strange Case Of Dr. Jekyll And Mr. Hyde (Jekyll and Hyde)
